- 6. Scope of work for Documentaries on Co-treatment of Faecal Sludge in operational STPs & Reuse of treated wastewater for various purposes
- a) WBSPMG will produce two (2) documentaries as part of its IEC (Information, Education, and Communication) initiative with the objectives to create awareness for mitigating pollution in the river Ganga and maintaining water balance in it under the titles:
  - Co-treatment of Faecal Sludge in operational STPs in West Bengal.
  - Reuse of treated wastewater for various purposes
- b) Scripts for the documentaries may be based on;
- i. Co-Treatment of Faecal Sludge in the functional STPs of West Bengal.
- For effective and comprehensive management of Sewage and Septage with an aim to reduce Faecal Coliform in River Ganga, Department of UD & MA, GoWB has framed and notified a policy on Faecal Sludge and Septage Management Policy for the Urban Areas in State of West Bengal vide Memo No. 33-UDMA/24011(99)/66/2021 dated 25.05.2022.
- Two FSTPs each having a capacity of 30 KLD at Promodnagar are now fully operational for treating Septage from North Dum-Dum, South Dum-Dum, Kamarhati and Baranagar Municipalities.
- Two Pilot projects (Siliguri and Kharagpur 30 KLD each) under supervision of IIT, Kharagpur are in the process of implementation.
- More FSTPs are either in the tendering stage or under review by NMCG for the installation of standalone FSTPs in the state.
- As of March 2024, a total of 2538.20 KL of septage has been cotreated in the operational STPs of Gayeshpur, Nabadwip, Barrackpore, Budge Budge, Halisahar, Chandannagar, and Chinsurah ULBs.
- ii) Re use of Treated Waste Water for different purposes to ensure water balancing in River Ganga.
- Managing wastewater is crucial for protecting water resources, including treatment to acceptable levels before discharging it into the environment.
- The concept of water balancing and impact of re using of waste water for maintaining e flow of Rivers including River Ganga is also crucial for protecting water resources.
- The National Water Policy of 2012 mandates the recycling and reuse of treated waste water and specifies standards for its treatment before reuse.
- The National Urban Sanitation Policy (NUSP), under the Ministry of Housing and Urban Affairs, Government of India, sets a target of reusing 20% of urban wastewater.

- Power tariff policy mandates thermal power plants within 50 kms of a city STP to off take all the treated waste water from the STP
- UD & MA Department, GoWB has framed a policy "Treated waste water re -use policy of urban West Bengal in 2020. For re use of treated waste water.
- In West Bengal, following areas have been identified for re use of treated waste water: Irrigation and agriculture, Community latrine and toilet flushing, Road cleaning, construction activities, Pisciculture, Car washing, Maintenance of parks gardens and developing urban landscaping, Rejuvenation of ponds, lakes, rivers and Emergency purposes for the fire brigade
- Presently, State is utilizing treated waste water for the following purposes.

Pisciculture: Durgapur, EKW, Nabadwip, Murshidabad.

Gardening: Durgapur, Halisahar.

Road cleaning: NKDA.

- DVC has mapped the proposed STPs at Asansol & Durgapur for Re-use of treated waste water in their Durgapur Steel Thermal Power Station (DSTPS)
   Action Plan is getting prepared for using treated water of Budge Budge STP in the CESC Thermal Power Station Unit at Budge Budge.
- The WBSPMG is trying to reuse wastewater from more functional STPs in the state.
- East Kolkata Wet Land (EKW): An internationally recognized natural STP. 910MLD domestic sewage is getting treated in a Natural Treatment System, which is being regularly re-used in Pisciculture (910 MLD).
- c) Documentaries would be of Five minutes duration each.
- d) The documentaries are to be developed so that flexibility would be there in using different segments of varying lengths for diverse audiences on different occasions. With respect to time duration, 15 Sec, 30 Sec, 1 Minute and Documentary as a whole may be considered.
- e) Both documentaries will be bilingual, with versions in English and Bengali, and subtitles in Bengali and English respectively

- f) The output specifications of the Documentary Films Visual and Audio quality would be 4K and 5.1 digital surround sound (preferred sample rate 48 kHz, sample size 24 bites) along with [another copy] HD quality Visual and Stereo sound.
- g) Visual (Movie including drone videography & still photograph), 2D and 3D animation template, Voice over, Byte, Interview of specialized & responsible persons, Foley, Location sound, Background music, Textual component etc. shall be the integral component of the documentary films.
- h) During the various phases (Pre-production, Production and Postproduction) of making the films, all creative and other major decisions would be made upon by the consultation with WBSPMG and subsequent approval thereto.
- i) The script of the documentaries is to be written based on the concept note furnished above. However, members of the Technical Committee, UD&MA will be holding a pre-bid meeting with the prospective bidders to brief them and answer any queries raised by the prospective bidders in this regard.
- j) The script of documentaries and primary drawing of 3D animation must be approved by the WBSPMG.
- k) The voice over on the documentaries is to be given by an Artist having sufficient experience in the field. The Agency is to submit voice samples of at least 3 Artists for approval of one by the WBSPMG.
- To ensure quality of the documentaries, Guidance and Instructions given by the WBSPMG is to be incorporated in course of making of documentaries and continuous consultation with WBSPMG is to be made so that no areas remain uncovered.
- m) The logo to be used in the documentaries will be provided by WBSPMG in soft form.
- n) Post Production is to be done as per requirement of WBSPMG.
- o) Still Photography & Videography of the Film Making is to be provided by the agency during production stage.
- p) The documentaries produced and submitted in draft form will be

q) Interviews of the Officials / Experts to be selected by WBSPMG on the subjects are to be taken for incorporation in the respective documentaries. Bytes of local people would be used according to need.

9.	Acceptance of Tender	Lowest valid rate should normally be accepted. However, the tender accepting authority does not bind him to accept the lowest Bid and reserves the right to reject any or all of the Bids received without assigning any reason thereof. Letter of Intent (LOI) will be issued to the successful bidder.
10.	Intimation	The successful Bidder will be notified in writing of the acceptance of their Bid. The Bidder then becomes the "Contractor" and he shall forth with take steps to execute Formal Contract Agreement in appropriate Form and fulfil all his obligations as required by the Contract.
11.	<b>Escalation of Cost</b>	There will be no escalation in cost on contract price.
12.	Execution of Work	The Contractor is liable to execute the whole work as per direction and instruction of the WBSPMG.
13.	Payment	Payment will be made after successful completion of the work.

- 15. Persons having authenticated and having registered Power of Attorney may be considered lawfully be coming to be acting on and for behalf of the Bidder.
- 16. Sufficient care has been taken to avoid variance in between the contents of the uploaded/listed documents in the Bid documents. However, if there is any variance between the contents of different documents, the bidder should draw those in the notice of Tendering Authority. In case of any variances or discrepancies noticed by the bidder/contractor after opening of the tender, decision of the Tendering Authority shall be final and binding to the Contractor.

- 23. The Bidder at the Bidder's own responsibility and risk is encouraged to visit and examine the site of STPs/FSTPs/Re-use of treated waste water works under control of WBSPMG and its Surroundings and obtain all information that may be necessary for preparing AUDIO-VISUALS for the work as mentioned in the Notice Inviting Tender. The cost of visiting the site shall be at the Bidder's own expense. Traffic management during execution shall be the responsibility of the Agency at his/her/their risk.
- 24. During scrutiny, if it is come to the notice of the tender inviting authority that the credential or any other papers found incorrect/manufactured/fabricated, that bidder will not be allowed to participate in the Tender and that application will be out rightly rejected without any prejudice.
- 25. Before issuance of the work order, the tender inviting authority may verify the credential & other documents with the original of the lowest bidder if found necessary. After verification, if it is found that such documents submitted by the lowest bidder is either manufactured or false, in that case, L.O.A. / work order will not be issued in favour of the bidder under any circumstances.
- 26. The various documents comprising the full set of tender documents are complementary to one another and are to be taken as parts of a complete whole and mutually explanatory.
- 27. Where an individual person holds a digital certificate in his own name duly issued to him against the company or the firm of which he happens to be a director or partner, such individual person shall, while uploading any tender for and on

### 1. Registration of bidder:

Any bidder willing to take part in the process of e-tendering will have to be enrolled and registered with the Government e-procurement system, through logging onto <a href="www.wbtenders.gov.in">www.wbtenders.gov.in</a> The bidder is to click on the link for e-tendering site as given on the web portal.

### 2. Submission of Tender:

### 2.1 General process of submission

Tenders are to be submitted online through the website stated. All the documents uploaded by the Tender Inviting Authority form an integral part of the contract. Bidders are required to upload all the tender documents along with the other documents, as asked for in the tender, through the above website within the stipulated date and time as given in the Tender. Tenders are to be submitted in two folders at a time for each work, one is Technical Proposal and the other is Financial Proposal. The Bidders shall carefully go through the documents and prepare the required documents and upload the scanned documents in Portable Document Format (PDF) to the portal in the designated locations of Technical Bid. He needs to fill up the rate of item in the BOQ, downloaded for the work, in the designated Cell and upload the same in designated location of Financial Bid. The documents uploaded are virus scanned and digitally signed using the Digital Signature Certificate (DSC). Bidders should specifically take note of all the addendum / corrigendum related to the tender and upload the latest documents as part of the tender.

### 4.2 Tender Evaluation Committee (TEC):

Tender evaluation committee will evaluate Bid proposals of the ten bidders.

4.3 Uploading of summary list of technically qualified Bidders.

Pursuant to scrutiny of technical details of prospective bidders, Technical Evaluation committee will shortlist the eligible bidders provisionally. They will be called for making presentation before the committee on a specified date on audio visual works done previously and submitted as credential. Based on presentation made by the provisionally selected bidders, technical evaluation committee will prepare a final list of eligible bidders which will be uploaded in the web portals.

i. In making evaluation, the Committee may call the bidders and seek clarification/information or additional documents or original hard copy of any of the documents already submitted and if these cannot be produced within the stipulated time frame, their proposals will be liable for rejection.

### 4.4 Opening and evaluation of Financial Proposal:

- (i) Financial proposals of the bidders declared finally technically eligible by the Tender Evaluation Committee will be opened electronically by the Tender Inviting Authority from the web portal stated above on the prescribed date.
- (ii) The encrypted copies will be decrypted and the rates will be read out to the bidders remaining present at that time.
- (iii) After opening of the financial proposal, the preliminary summary result containing inter-alia, name of bidders and the rates quoted by them will be uploaded.
- (iv) If the Tender Accepting Authority is satisfied that the rate obtained is fair and reasonable and there is no scope of further lowering down of rate, he may after having the comparative statement checked, upload the final summary result containing the name of contractors and the rates quoted by them.
- **5.** The Tender Accepting Authority may ask any of the bidders to submit analysis to justify the rate quoted by those bidders.
